### ORDER

In the Government Order read as 1st paper above Administrative Sanction was accorded for an amount of Rs.60 lakh for the various Schemes launched by Kerala State Welfare Corporation for Forward Communities Ltd, meeting the expenditure under the head of account '2235-02-190-97-34-OC (P)'

As per the Government order read as second paper above an amount of Rs.12 Lakh has been released to the Manging Director as first instalment . Now the MD in his etter read above has requested to release the balance amount of Rs.48 Lakh allocated under the head of account '2235-02-190-97-34-OC (P)' for meeting the expenses in connection with the operational cost earmarked for the schemes to be launched by the Corporation during the current financial year(2023-24).

	The Corporation shall furnish duly authenticated detailed component wise

*	statement of expenditure and utilization certificate in prescribed form as appended to the G.O.(MS)No.04/2020/Fin dated, 09.01.2020.
*	If there is un-utilized amount at the end of this financial year that should be refunded to the Government during the financial year itself.
