ORDER

Central and State governments have enforced regulations in the form of lock down to contain the spread of Novel Corona Virus (Covid-19). As per the general orders read as paper 1 above, following are exempted:

- i. Hospitals and all related medical establishments including their manufacturing and distribution units.
- ii. Transportation of all medical personnel and other hospital support services.
- iii. Manufacturing units of all essential goods, including drugs, pharmaceuticals, medical devices, their raw materials and intermediaries.
- iv. Cross land border movement of medical supplies

2. As per letter read as paper 2 above, Additional General Manager, Amrita Institute of Medical Sciences, Kochi has informed that Amrita Vishwa Vidyapeetham in collaboration with Amrita Institute of Medical Sciences is engaged in developing the biomedical devices for corona patient support and hence requested Government to authorize them to procure and transport (intra and inter-state) of essential components, materials and equipments and allow the needed university staff to work on the project during the lock down period to speedily benefit the Covid-19 patients in the State.

3. Government, after examining the matter in detail are pleased to permit the procurement and transport (intra and inter-state) of essential components, materials and equipments that are helpful and required for the treatment of Covid-19 patients by all the institutions concerned. Permission is also granted for engaging the minimum personnel required for this purpose.
