The Proposal was placed before the Departmental Working Group meeting held on 19.05.2023 and Departmental Working Group recommended to approve the proposal with the following recommendations.

* As the implementation of most of the components involves conduct of trainings, surveys ,workshop etc detailed administrative sanction with cost break up should be issued by the Director before conduct of every programmes.
* If honorarium or travelling need to be paid to any of the incumbents deployed for the Implementation of the programs , the rate of such honorarium should be get approved by the government.
* For institution of awards and if it involves monetary award separate AS to be issued

	by the AD for institution of the award.
*	Any financial entitlement allowed to outside organisations other than the Government institutions should be subjected to the prior approval.
*	If any amount to be Paid to agencies other than Government institutions for curriculum preparation such rates should receive prior approval.
*	In addition to the Statutory audit by the Accountant General steps may be taken to get audited the accounts of both the organisations by the State Audit department.
*	Audited accounts of the SSA and KYLA for the Previous financial years will be verified by the AD to see that all expenditure made are as per financial principles and no adverse comments there.
*	Disbursing of salary and allowances to all temporary employess engaged in Samoohika Sannadhasena Directorate should be made through SPARK.
*	No appointment should be made for implementation of any programme without the approval of the government.

Having examined the proposal and recommendations of Departmental Working Group in detail, Government are pleased to accord Administrative Sanction to the Director, Samoohika Sannadhasena to implement the aforesaid Schemes to be launched by the Directorate for an amount of Rs.50 lakh (Rupees Fifty lakh only) allocated under the head of account 2053-00-094-37(P) during the Current financial year (2023-24), in line with the decisions taken at the Departmental Working Group.
