ORDER

In supersession of the Government Orders issued in the matter read above for extending State Hospitality to the visiting dignitaries, Government are pleased to issue the following modified guidelines governing extension of State Hospitality to the dignitaries visiting the State.

The visiting dignitaries are classified into three groups as listed in Table A, B and C.

- 1. Those included in Table-A will be declared as **State Guests** during their visit to Kerala, irrespective of the nature of visit.
- 2. Those in Table-B will be treated as **Guests of Government**, if their visit is for official purposes.

3. Those in Table-C will be treated as Guests of Government, if their visit is for official purposes in connection with a programme hosted/convened by Kerala Government or they visit the State as a part of Central Government Project meant for the State. The recommendation from department concerned that hosts/implement the programme/project shall be obtained for this purpose.

- * Note:—(1) At present the State Government has reciprocal arrangements with the States of Andhra Pradesh, Tamilnadu, (Puducherry, Telangana and Tripura. ie. If a dignitary holding a particular office of Kerala is considered as State guest in other State/UTs, this State shall also treat a dignitary holding analogous post in that State/UTs as State guest while visiting our State.
 - Note:—(2) Personal Staff up to a maximum number of three accompanying the State guests listed in Table A will be given hospitality at State expense for boarding, lodging and transportation. For category B and C the dignitary alone will be given hospitality at State expense. The period for providing guests facilities will not exceed five days for the dignitaries mentioned in Table A and three days for the dignitaries mentioned in Table B and C.
 - Note:—(3) Other dignitaries/officials on official visits may be given vehicle and accommodation, on spot payment basis, on specific request from the officer concerned.
 - Note:—(4) Whenever government desires to treat any other dignitary as State guest/ Guest of Government, it may be done after taking orders of the Chief Minister.
 - Note:—(5) Security arrangements for the guests would be made as per the provisions laid down by Government of India, Home (Department of State Government and in accordance with the directions from General Administration (Political) Department.

Note:—(5) Separate Government order is not required for the departments concerned to make protocol/hospitality/security arrangements during the visits of dignitaries listed in Table A.
