## ORDER

As per amended version of Rule 10 of Kerala Freedom Fighters' Pension Rules read as 2nd paper above, widows of freedom fighters are eligible for Kerala Freedom Fighters' Continuous Pension till their re-marriage or death irrespective of income and they are not eligible for Kerala Freedom Fighters' Continuous Pension if they are receiving any other pension other than Central Freedom Fighters' Continuous Pension

But many petitions received from Treasury Officers and also from applicants stating that Accountant General, Kerala objects their cases and stopped their Kerala Freedom Fighters' Continuous Pension, as they are recipients of Service pension. As per letter read as 3rd paper above Accountant General sought clarification on whether the applicants drawing Kerala Freedom Fighters' Continuous Pension along with Service Pension or any other pension before 08.11.2010 are eligible to draw Kerala Freedom Fighters' Continuous Pension.

Government have examined the matter in detail and are pleased to order that the G.O read as 2nd paper above shall have effect from the date

of order i.e, 08.11.2010 as the order does not have any retrospective effect. The Continuous pension already sanctioned to the widows of freedom fighters before 08.11.2010 are exempted from the conditions stipulated in Rules 10 & 11, as the G.O read 2<sup>nd</sup> paper above have no retrospective effect.

The Government Order read as second paper above stands modified to this extent.
