The undersigned is directed to state that 01 vacancy in the following grade, is proposed to be filled in the Department of Atomic Energy by composite method (Promotion/ Deputation):-

2. As per the RRs (copy enclosed), the post is to be filled amongst the following officers on deputation:

(1) Officers of All India Services or Central Civil Services Group 'A':-

(a) (i) holding analogous post on a regular basis in the parent cadre or department; or (ii) with two years of regular service in Level 13A (Rs. 131100-216600) in the Pay Matrix in the parent cadre or department; or (iii) with three years of regular service in Level 13 (Rs. 123100-215900) of the Pay Matrix in the parent cadre or department;

and

(b) Possessing the following educational qualification and experience, namely:-

- (i) Graduate in any discipline from a recognized University;
- (ii) Experience required in the areas of Personnel Management, General Administration, Finance, Procurement and Inventory Management in a Government office or Autonomous Institution or Public Sector

3. The eligibility conditions for the post of Controller, BARC, are mentioned in **Annexure-A**.

4. In case of deputation, it shall be governed by the terms and conditions stipulated in the DoPT O.M. No. 6/8/2009-Estt. (Pay-II) dated 17.06.2010 as amended from time to time.

5. The period of deputation shall be for 05 years and further extendable as per the guidelines of DoPT OM No. 6/8/2009-Estt. (pay-II) dated 17.6.2010 & OM No. 2/6/2018-Estt (Pay-II) dated 18.5.2018, subject to further requirement and performance of the Officer.

6. In order to reward the performance of an organization within Department of Atomic Energy and the role of the personnel in realizing its objectives, Performance Related Incentive Scheme (PRIS) is introduced which is the variable component of the pay and is awarded on the basis of the performance of the individual/group/organization measured against set goals, during the period of assessment. Accordingly, the selected Officer will be eligible to get the PRIS amount based on his performance and other components like APAR gradings, attendance and vigilance clearance.

7. The application of willing and eligible officers, who have completed cooling off period of 3 years since last deputation (if applicable), and have undergone more than 1 deputation prior to this and who can be spared immediately, if selected, may be forwarded along with the following documents so as to reach the Deputy Secretary (Cadre), Department of Atomic Energy, Anushakti Bhavan, CSM Marg, Mumbai - 400 001, latest by 27.03.2025.

- (i) Bio-data (as per **Annexure-B** specimen attached) (06 copies), duly filled and signed by the candidate, along with attested copies of relevant educational/training certificates and forwarded through proper channel, duly signed certificate of cadre controlling authority.
- (ii) Attested copies of their APARs for the preceding 5 years.

- (iii) Vigilance clearance certificate, duly signed by cadre controlling authority, including a statement of major/minor penalties, if any, imposed on the officers during the last 10 years.

Since, the appointment is to be made urgently, it is requested that the closing date for receipt of applications mentioned above may please be adhered to, strictly.
